### **Exercise of Options and Total Voting Rights**

Omega Diagnostics (AIM: ODX), the medical diagnostics company focused on CD4, infectious diseases and food intolerance testing, announces that it has allotted 38,043 new ordinary shares of 4 pence each in the capital of the Company (“Ordinary Shares”) following the exercise of share options by an ex-employee.

Application has been made to the London Stock Exchange for the 38,043 new Ordinary Shares to be admitted to trading on AIM (“Admission”) and it is expected that Admission will become effective and trading will commence at 8.00 a.m. on 15 October 2020.

After Admission, the total number of Ordinary Shares in issue will be 178,716,153 and the total number of voting rights will therefore be 178,716,153. This figure may be used by shareholders as the denominator for the calculations by which they will determine if they are required to notify their interest in, or a change to their interest in, the share capital of the Company under the FCA’s Disclosure and Transparency Rules.
