Exercise of Options and Total Voting Rights

Omega Diagnostics (AIM: ODX), the medical diagnostics company focused on CD4, infectious diseases and food intolerance testing, announces that it has allotted 141,846 new ordinary shares of 4 pence each in the capital of the Company (“Ordinary Shares”) following the exercise of share options under the Company’s Sharesave scheme by certain option holders.

Application has been made to the London Stock Exchange for the 141,846 new Ordinary Shares to be admitted to trading on AIM (“Admission”) and it is expected that Admission will become effective and trading will commence at 8.00 a.m. on 19 November 2020.
