Exercise of Options and Total Voting Rights

Omega Diagnostics (AIM: ODX), the medical diagnostics company focused on CD4, infectious diseases and food intolerance testing, announces that it has allotted 26,412 new ordinary shares of 4 pence each in the capital of the Company (“Ordinary Shares”) following the exercise of share options under the Company’s Sharesave scheme by certain option holders.
